

Abstract

The key economic importance of textiles and textile production, as well as their formative socio-cultural role in past societies, have been properly recognised due to recent advancements in textile studies. The current comprehensive framework of textile research in Greece encompasses all available evidence, including excavated textiles, textile tools, workshop remains, zooarchaeological and archaeobotanical data, as well as textual, iconographic and experimental sources. In the case of Aegean textiles, their notable economic and ritual value has been identified due to their prominent presence in Linear B records, their potential premonetary function, rich iconography, and large-scale production centres. Additionally, their value can be deduced according to the 'time-money' relationship, as formulated by Eero Jarva and Sanna Lipkin in 2014, derived from the substantial workloads associated with raw materials, applied techniques, and acquiring skills.

The primary focus of my talk, however, is a less conspicuous yet significant body of evidence: threads and cords and their use-patterns in the Bronze Age Aegean. My studies, currently being expanded by two new projects: *Textile digitisation tools and methods for cultural heritage* [*TEXTaiLES*, ECCCH by HORIZON REA ID 101158328]; and *Exploring textile imprints on clay from the 3rd and the 2nd millennia BCE* [*ExplorTIC*, by the National Science Centre in Poland, ID 2023/50/E/HS3/00094], are based on textile imprints on clay sealings stored (as copies) in the Archive of the *Corpus der minoischen und mykenischen Siegel* in Heidelberg. My aim is to highlight the potential value of these seemingly simple and utilitarian products. I will discuss their qualities, including their technical and aesthetic properties, as well as their possible symbolic significance. I will also present a few recognised use-patterns for threads and cords in administrative and sealing practices, indicative of their apparent reusing and recycling.
